There is no any vehicle to take them to the school. There is no any good road either. So, many of the learners are not able to attend the class,

Most of the parents are farmers or working in others farms. Their economical condition is weak. The parents are hardly literate. Many of the learners go for the work in hotels or in the farm for money. So, there is very less awareness of education. As a result of which learners do not get much exposure to the language and get needed facilities and equipment.

Almost most of the schools have been teaching English language in their mother tongue. The teachers use bilingual method because of which the learners feel comfortable using their mother tongue instead English. The learners are being taught English as a content subject not a skill subject. They are expected to recite the rules, recite the text and copy them into their examination. Most of the classes are teacher centric not a learner centric. The learners hardly get a chance to communicate, discuss the topic in the class. As a result of which the learners become shy. Many learners from the rural areas have lack of learning resources. The overcrowded classes are the major factor for the learning English language in the rural area. Because, the teachers have to teach the whole syllabus, take attendance, etc. in a very limited time. So they don't give importance to feedback or assessment seriously. They only teach and move on to next class or topic.

The major problem is that the learners are not being motivated. They don't have awareness for learning English language. They don't want to learn English. They don't know the importance, its value in their day to day life. Their attitude towards English is very negative. The learners have fear about English in their mind. On the other hand, there are some teachers who are also not well trained and competent in their language. They don't have their library. They themselves do not know the language well. They how can they teach their students effectively?
