Beloved by Toni Morrison

“White people believed that whatever the manners, under every dark skin was a jungle. Swift unnavigable waters, swinging screaming baboons, sleeping snakes, red gums ready for their sweet white blood. In a way . . . they were right. . . . But it wasn't the jungle blacks brought with them to this place. . . . It was the jungle whitefolks planted in them. And it grew. It spread . . . until it invaded the whites who had made it. . . .”(Beloved 199)

References to Christianity

Taken from Romans 9:25, Beloved's epigraph captures the presence Christian ideals will bring about in the book. The "four horsemen" that visit Sethe draw on the book of Revelation's account of the Apocalypse. Beloved returns into Sethe's realm covered in a sort of baptismal water. Denver eats her sister's blood as well as her mother's breast milk as a newborn, which would be seen as a Communion act tying Denver and Beloved together and stressing the baby's sacrifice in death. Sethe's actions so horrify the schoolteacher that he leaves without bringing her other children with him, therefore letting them to live free. Like Christ, the baby's martyr death gives atonement. Similar resounding with biblical references are the book's more thorough debates of sin, sacrifice, redemption, forgiveness, love, and resurrection.
