Karnataka, a state in southern India, is home to several indigenous tribal communities that play a vital role in the state's cultural diversity and heritage. These tribes have distinct languages, customs, and lifestyles, contributing to Karnataka's rich social fabric. Some of the major tribes in Karnataka include:

- **1. Soliga Tribe:** Primarily found in the Biligirirangan Hills (BR Hills), Male Mahadeshwara Hills, and surrounding areas in southern Karnataka. Traditionally semi-nomadic, the Soligas practice shifting agriculture, hunting, and gathering forest produce. They also engage in hunting, gathering, and small-scale agriculture. The Jenukurubas maintain a unique relationship with the forest, and their customs revolve around the forest's offerings. They speak the Jenukuruba dialect and have a distinct set of religious practices and folk traditions.
- **3. Kadukuruba Tribe:** Found primarily in the Western Ghats and Mysore districts. Traditionally, the Kadukurubas are hunters and gatherers. Over time, many have settled in villages and practice agriculture, animal husbandry, and labor work. They have their own dialect and maintain distinct customs, especially related to nature worship. Their dances and folk songs are often associated with forest life.
- **4. Yerava Tribe:** Concentrated in the Kodagu (Coorg) region and along the Karnataka-Kerala border. The Yerava people traditionally worked as laborers in coffee plantations and in agriculture. They are known for their deep connection to the land and forest, and many Yeravas still rely on farming and forest-related activities. The Yerava have their own language called Yerava, and they practice unique customs and rituals. Their folk dances, music, and festivals reflect their tribal heritage.
- **5. Koraga Tribe:** Primarily found in the coastal districts of Karnataka, such as Udupi, Dakshina Kannada, and Uttara Kannada. The Koraga people have traditionally been involved in occupations like basket weaving, drum-making, and other forms of manual labor. They are among the more marginalized tribal communities in Karnataka. The Koraga tribe follows its own religious practices and social customs, and they have a distinct language called Koraga. They are known for their unique music and rituals, often associated with traditional ceremonies.
- **6. Gond Tribe:** Found in the northern districts of Karnataka, especially in the Bidar and Gulbarga regions. The Gonds are one of the largest tribes in India and practice agriculture, hunting, and gathering. Many Gonds have also integrated into mainstream society, engaging

They are known for their traditional herbal knowledge and are recognized for their skills in natural medicine.
- **9. Iruliga Tribe:** Found in the Ramanagara, Mysore, and Tumkur districts. The Iruligas are traditionally forest dwellers and hunters.
