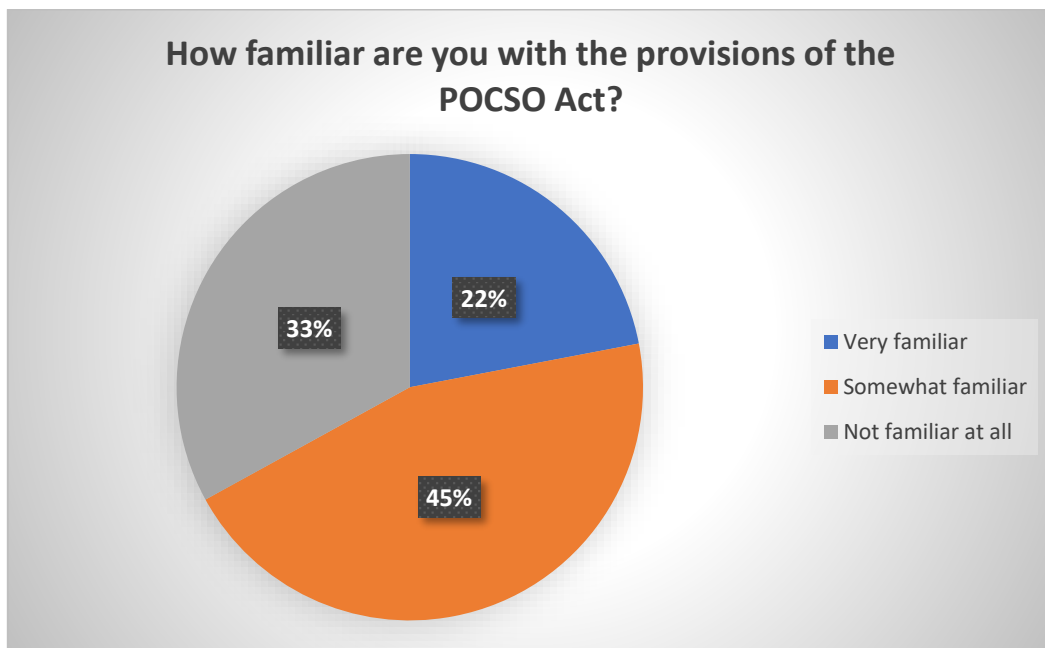


Figure 1: POCSO Act wise distribution of respondents

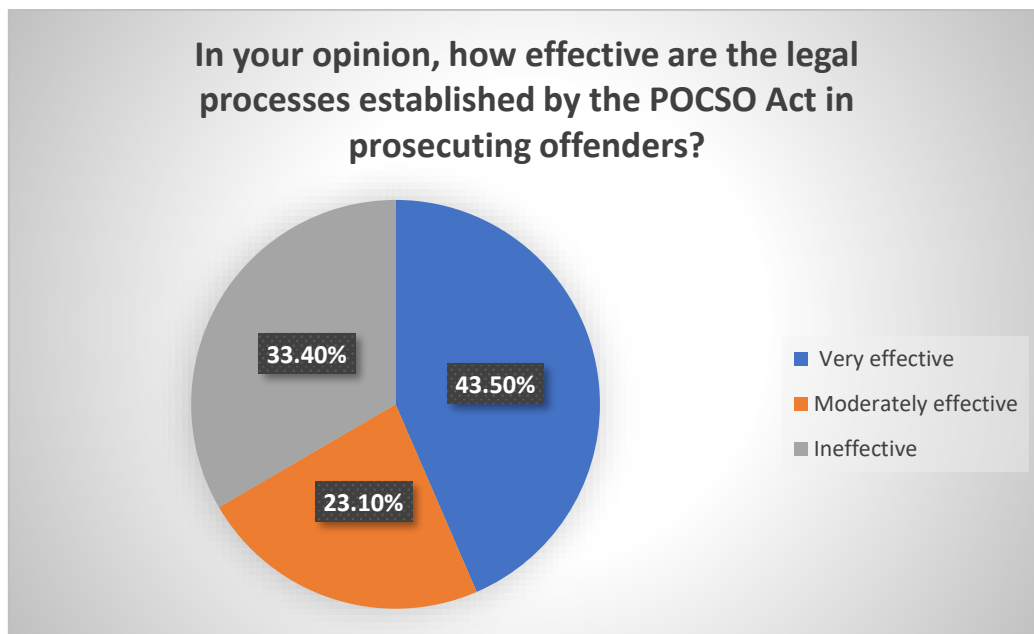


Figure 2: Legal processes wise distribution of respondents

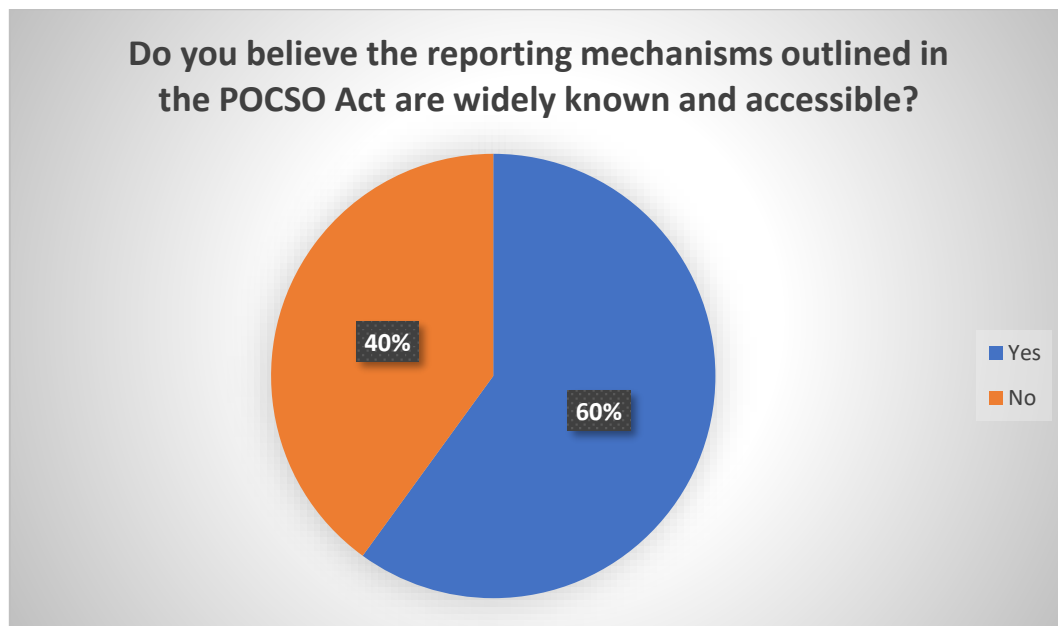


Figure 3: Reporting mechanisms wise distribution of respondents

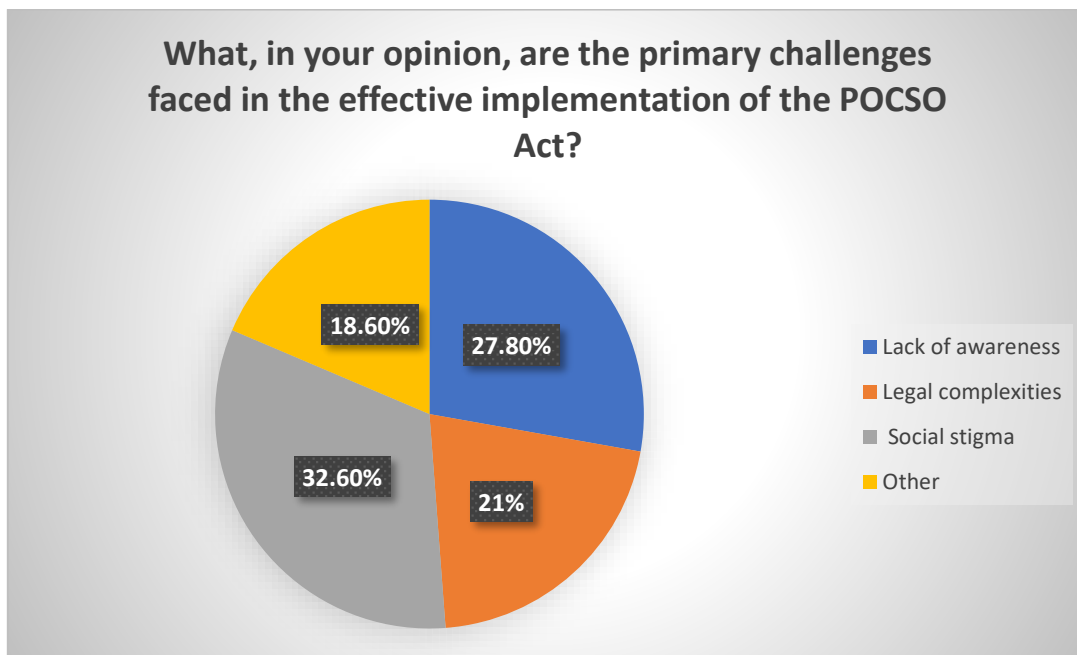


Figure 4: Primary challenges wise distribution of respondents

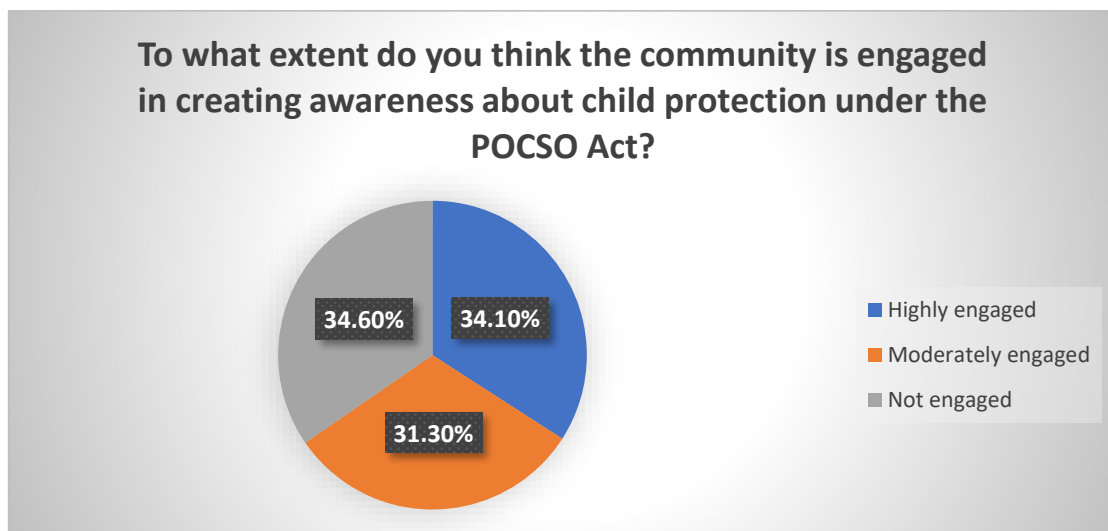


Figure 5: Creating awareness wise distribution of respondents
